The licence holder must produce the logbook to the Minister for inspection, when requested.

MW0632-00001

The licence holder must keep a log book, except where the access licence nominates only a metered work with a data logger. A "logbook" means a written record, kept in hard copy or electronic form,

which accurately records all information required to be kept for this licence.

MW0637-00001

The licence holder must retain the information required to be recorded in the logbook for 5 years from the date to which that information relates.

Reporting

MW0831-00001

The licence holder must notify the Minister, in writing, immediately upon becoming aware of a breach of any condition of this licence. Note: a notification does not authorise a breach, or continuing breach, of a condition of this licence.

Additional conditions

MW0718-00001

The maximum water allocation that may be carried over in the water allocation account for this access licence from one water year to the next is either:

- (A) 10 % of the access licence share component for access licences with share components expressed as ML/year; or
- (B) 0.1 ML per unit share of access licence share component for access licences with share components expressed as a number of unit shares.
